1 Introduction

1.1 Purpose of the Coordination Plan

The Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) was enacted in 2005. The SAFETEA-LU addresses the many challenges facing our nation's transportation system, such as improving safety, reducing traffic congestion, improving efficiency in freight movement, increasing intermodal connectivity, and protecting the environment. In 2012, the provisions of Section 6002 of SAFETEA-LU were amended by Section 1305 of Moving Ahead for Progress in the 21st Century Act (MAP-21) and further refined in 2015 by 1304(g) of Fixing America's Surface Transportation Act (FAST Act).

Section 6002 of SAFETEA-LU requires the lead agencies for any federally funded project performing an Environmental Impact Statement (EIS) to establish a plan for coordinating public and agency involvement during the environmental review process. MAP-21 continued this requirement, and the FAST Act added that the Coordination Plan is required no later than 90 days after the publication of the EIS Notice of Intent (NOI) and must include a schedule.

The Arizona Department of Transportation (ADOT) will act as the lead agency for environmental review, interagency coordination without federal participation, and coordination with Federal Highway Administration (FHWA) monitoring and audits. The FHWA retains some engineering decisions, project-level air quality conformity determinations, and government-to-government Tribal consultation (if requested). The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by ADOT pursuant to 23 U.S. Code (U.S.C.) 327 and a Memorandum of Understanding dated June 25, 2024, and executed by the FHWA and ADOT.

Agency and stakeholder roles and responsibilities, which are contained in 40 Code of Federal Regulations (CFR) Parts 1500-1508 National Environmental Policy Act (NEPA) Implementing Procedures and 23 CFR Part 771 Environmental Impact and Related Procedures, are defined below. The agencies will also adhere to guidance contained in 23 U.S.C. 139 Efficient Environmental Reviews for Project Decision-Making.

This Project Coordination Plan for agency, public, and Tribal involvement defines the process by which ADOT will communicate information about the study to the Cooperating agencies, Participating agencies, the public, and Tribes. The plan also identifies how input from agencies, Tribes, and the public will be solicited and considered, as well as facilitating and documenting the lead agencies' interaction with other agencies, the public, and Tribes. The plan's other purposes include:

- Identifying early coordination efforts
- Identifying Cooperating and Participating agencies
- Establishing the timing and methods for gathering Cooperating and Participating agencies' input on the project's purpose and need, study area, range of alternatives, study methodologies, technical reports, findings of the Draft EIS, preferred alternative, and mitigation strategies



- Establishing the timing and methods for gathering public input on the project's purpose and need, study area, range of alternatives, issues of concern, environmental features, and findings of the Draft EIS
- Describing the communication methods for informing the community about the project
- Establishing a conflict resolution process for the Cooperating agencies

A separate public involvement plan has also been developed for the project. Both this plan and the public involvement plan will be updated periodically to reflect any changes to the project schedule and other items that may require updating over the course of the project.

1.2 Background and Study Description

ADOT is conducting engineering and environmental studies for the North-South Corridor Design Concept Report (DCR) and Tier 2 Environmental Study from U.S. Highway 60 (US 60) to Arizona Farms Road (Segment 1), known as North-South Corridor Segment 1, in Pinal County, Arizona. The North-South Corridor Segment 1 study will build upon the prior Tier 1 EIS process, which concluded in November 2021 and established the general location of a new proposed 50-mile-long highway route between US 60 to the north and Interstate 10 (I-10) to the south in Pinal County. The Selected Alternative in the Tier 1 Record of Decision (ROD) was a 1,500-foot-wide corridor within which subsequent Tier 2 studies would identify the specific 400-foot highway alignment.

The concept of a new north-south transportation facility in Pinal County has been acknowledged in local, regional, and statewide plans since the early 2000s. The formal process of studying the North-South Corridor began in 2010 with a project-level EIS and ultimately concluded with the Tier 1 ROD in 2021. Chapter 1 of the *Tier 1 Final EIS and ROD* (https://azdot.gov/planning/transportation-studies/north-south-corridor-study-proposed-new) describes the transportation planning efforts in the vicinity that led to the Tier 1 study process. Since 2021, ADOT, the Maricopa Association of Governments (MAG), Pima Association of Governments, Pinal County, and other local government agencies have continued to address the transportation needs and solutions in Pinal County. ADOT is coordinating with the study teams of the following studies, which are separate projects from the North-South Corridor Segment 1 study:

- MAG Superstition Vistas Multimodal Transportation Planning Study
- Pinal County State Route 24 Extension
- Pinal County Central Arizona Parkway

1.3 Project Purpose and Need

Projected population and employment growth would increase travel demand, and the current connection between US 60 and I-10 in Pinal County is a fragmented assortment of rural roads with missing linkages throughout. While this fragmentation of north-to-south routes does not cause substantial congestion now, land use patterns, population, and employment growth would result in substantial congestion in the future. The analysis conducted for the Tier 1 EIS process revealed that a major north-to-south transportation facility is necessary in Pinal County to address the following needs—insufficient infrastructure to support projected growth and planning efforts, inadequate north-to-south transportation capacity that cannot meet future demands, a fragmented roadway network that lacks system connectivity and continuity, and limited alternatives to avoid congestion on I-10.



The purpose of the North-South Corridor is to provide a continuous, access-controlled, north-to-south transportation corridor that would improve access, regional mobility, and north-south connectivity; accommodate existing and future population growth; integrate the region's transportation network; and provide an alternative to avoid congestion on I-10.

Several goals were identified during the Tier 1 process that further aided the definition and evaluation of alternatives considered and will be considered during Tier 2 studies:

- Protecting and enhancing the natural environment along the corridor
- Supporting local and regional land use plans and preservation goals
- Supporting equitable economic opportunities
- Complementing other planned transportation improvements along new and established corridors in the study area

Technical information supporting the purpose and need identified in the Tier 1 study is available in Chapter 1 of the *Tier 1 Final EIS and ROD* (https://azdot.gov/planning/transportation-studies/north-south-corridor-study-proposed-new). This Tier 2 study will refine the purpose and need to focus on the segment of the project between US 60 and Arizona Farms Road.




Figure 2. Vicinity Map of the North-South Segment 1, US 60 to Arizona Farms Road



2 Lead, Cooperating, and Participating Agencies and Key Stakeholders

This section identifies the lead, Cooperating, and Participating agencies that will be involved in North-South Corridor Segment 1. It defines their roles and responsibilities and identifies several nongovernmental entities that will be key stakeholders.

2.1 Agency Roles and Responsibilities

The agencies discussed in this section (except for the lead agencies) have been formally invited by letter to participate in the study. All Cooperating and Participating agencies are responsible for:

- Participating in the scoping process
- Providing comments on the purpose and need, study methodologies and criteria, and range of alternatives
- Identifying issues of concern regarding the project's impacts on the natural and human environments
- Providing timely input on unresolved issues

2.1.1 Lead Agency

Through NEPA Assignment, ADOT has assumed the FHWA's responsibilities for complying with NEPA for most highway projects in Arizona. The environmental review and consultation as well as other actions required by applicable federal environmental laws for this project are being, or have been, carried out by ADOT pursuant to 23 U.S.C. 327 and a Memorandum of Understanding dated June 25, 2024, and executed by the FHWA and ADOT. Responsibilities associated with NEPA Assignment include review and approval of NEPA documents, interagency consultation and coordination, and environmental regulatory compliance. **Table 1** shows the lead agencies for this project, including their roles and responsibilities.

2.1.2 Cooperating Agencies

Cooperating agencies are specifically requested by the lead agency to participate during the environmental evaluation process for the project. NEPA regulations—codified in 23 CFR § 771.111(d)—require that those federal agencies with jurisdiction by law concerning the action (with permitting or land transfer authority) or with special expertise regarding any potential project-related environmental impact be invited to serve as Cooperating agencies for an EIS. A state, Tribal, or local agency with similar qualifications may also become a Cooperating agency by agreement with the lead agency.



Should a federal agency choose to decline Cooperating agency status, the agency will automatically be considered a Participating agency whether a written response is provided or not. If a federal agency should choose to decline both Cooperating and Participating agency status, the agency must submit a written response stating that it 1) has no jurisdiction or authority with respect to the project, 2) has no expertise or information relevant to the project, and 3) does not intend to submit comments on the project.

In accordance with Title 40 CFR 1501 and 23 CFR 771.111, eight agencies have been identified to have jurisdiction in the North-South Corridor or special expertise concerning the project. In December 2023, the agencies listed in **Table 2** were invited to serve as Cooperating agencies in the development of the study's NEPA document. **Table 2** also summarizes the responses received to the invitation. **Appendix A** provides a full list of agencies and contacts invited to serve as Cooperating agencies, and **Appendix B** contains copies of the Cooperating agency letters and acceptances.

2.1.3 Participating Agencies

Section 6002 of the SAFETEA-LU created a new category of agencies to participate in the EIS environmental review process—federal, state, Tribal, regional, and local governmental agencies with an interest in the project. Agencies invited to participate in the environmental review process are designated as a Participating agency unless the invited agency informs the lead agency, in writing, by the deadline specified in the invitation that it 1) has no jurisdiction or authority with respect to the project, 2) has no expertise or information relevant to the project, and 3) does not intend to submit comments on the project. Nongovernmental organizations and private entities cannot serve as Participating agencies.

Federal, state, Tribal, and local agencies were asked to respond affirmatively to the invitation to be designated as a Participating agency. If an agency failed to respond by the stated deadline or declined the



invitation, the agency is considered a stakeholder and will continue to receive periodic project information.

Table 3 lists the 13 agencies invited to be a Participating agency, and **Table 4** lists the 23 Tribal governments that were invited to serve as Participating agencies. Both tables provide the agency or Tribal government's response to the invitation. For those agencies that did not respond, dates of the follow-up outreach are noted in the table.

Accepting the designation as a Participating agency does not indicate support for the study nor does it provide the agency or Tribal government with increased oversight or approval authority beyond its statutory limits, if applicable. Meetings will be held with agencies and Tribal governments serving as Participating agencies on an as-needed basis to discuss specific subjects of interest, concerns, and recommendations. This review process will include key milestone meetings with agencies and Tribal governments serving as Participating agencies prior to the public information meetings and before the public hearings on the Draft EIS. Joint webinar updates will be held with agencies and Tribal governments serving as Participating agencies, as needed.

3 Coordination Activities

This section describes coordination activities to be conducted throughout the environmental review process, including initial coordination, coordination points (milestones), and distribution of information.

3.1 National Environmental Policy Act Process Coordination

In July 2023, ADOT initiated coordination activities for this Tier 2 study. Coordination activities have included an agency scoping meeting, various technical coordination meetings with agencies and Tribal governments, and the formal invitations to Cooperating and Participating agencies (described in Section 2 of this Project Coordination Plan). A round of public involvement was conducted in August and September 2023, and a summary of the meetings held and input received is available on the project website at https://azdot.gov/planning/transportation-studies/north-south-corridor-study-proposed-new-transportation-route-pinal. Other early coordination activities will include agency involvement in the development of a preliminary purpose and need and the range of alternatives to be considered for the project.

ADOT anticipates formally initiating the NEPA process in early 2025 by publishing a NOI in the *Federal Register*. This Project Coordination Plan would be updated at that time.

3.2 Coordination Points, Information Distribution, and Required Actions

Table 6 lists key coordination points (study milestones), including which agency is responsible for activities during each coordination point; the information required at each coordination point; how the lead agencies will make information available to Cooperating agencies, Participating agencies, and the public; and who is responsible for transmitting that information and by what means.

Table 6 also lists the anticipated timeline for each study milestone. Review times for documents distributed to Cooperating and Participating agencies at each coordination point are 30 calendar days, unless noted otherwise. It is important to note that the schedule is subject to change and that periodically through the EIS process the schedule in the Project Coordination Plan will be updated to reflect the current approach and understanding. When these changes are made to update the schedule, an email notice will be sent to the Cooperating and Participating agencies and the Project Coordination Plan will be updated on the project website.

5 Tribal Involvement

The Tier 1 study identified substantial interest from several Native American Tribes, and the Tier 2 study area is within the ancestral lands of multiple Native American Tribes. ADOT will continue to coordinate and regularly report on the study's progress with the Tribal governments throughout the EIS and Section 106 process in accordance with policies and procedures established by ADOT and/or the FHWA. Section 106 consultation will follow procedures maintained by ADOT's historic preservation team and 36 CFR 800. ADOT will ensure Tribes, in particular cultural resources staff, are involved in project development beyond the scope of only the Section 106 process. Tribal governments' participation in the NEPA process and understanding the project as a whole are important to the overall process, including the development of the projects' purpose and need and alternatives development, as well as other project considerations such as the identification of biological resources and environmental justice communities and impacts. ADOT will communicate with the Tribes throughout the NEPA process.

To support our commitment to working with Tribal governments, ADOT employs a Tribal relations team with two department-wide Tribal liaisons, a Native Nations Ambassador in the State Engineer's office, a Contract Agent in the Right-of-Way Group, and a Tribal liaison with ADOT Environmental Planning. Together, this team will keep Tribes informed, consulted, and aware of this project.

The Tribes were notified of the public meetings in September 2023 and will be notified about any future public information meetings or public hearings to be conducted. ADOT formally invited all 22 federally recognized Tribes in Arizona to be Participating agencies in the NEPA process, as well as the Mescalero Apache Tribe in New Mexico.

ADOT will continue to hold breakout meetings as the cultural studies progress to provide status updates, discuss methodology, share technical information, and discuss findings and recommendations. ADOT will accommodate similar meetings with the other Tribes if requested.



6 Public Outreach

6.1 Outreach Conducted to Date

Public outreach was conducted in August and September 2023 to provide the public with an overview of the recently initiated study and solicit public input to be considered when developing the range of feasible alternatives for the North-South alignment, interchange locations, and other features. A public comment period was open from August 28 through September 27, 2023. A summary of the outreach conducted and input received is documented in the Public Involvement Summary Report available on the project website at https://azdot.gov/sites/default/files/2024-03/North-South-Tier-2-Public Involvement-Summary.pdf.

6.2 Continued Outreach

ADOT developed a Public Involvement Plan for the North-South Tier 2 Corridor Study in compliance with the FHWA and other federal and state regulations. The EIS process conducted for the North-South Tier 2 Corridor Study will promote informed decision-making by federal, state, and local agencies.

ADOT will continue the collaboration, communication, and cooperation between all who are involved in environmental decisions, including government officials, private businesses, and the public as the project moves through the NEPA process.

Stakeholder and public input continue to provide important insight as the project team analyzes constraints within the 1,500-foot Tier 1 Corridor to identify a specific alignment for the North-South Segment 1, Tier 2 EIS and DCR. Public input will be integrated into the evaluation process before decisions are made.



7 Conflict Resolution

SAFETEA-LU provides a formal process for resolving serious issues that may delay the proposed project or may result in denial of a required approval for the proposed project. ADOT or the Governor of Arizona may invoke the Section 6002 process for issue resolution at any time. However, the conflict resolution process discussed below should be considered the first option for issue resolution prior to invocation of Section 6002.

Should an issue come to an impasse, the general process for addressing and resolving the issue would be:

- 1. Involved parties will identify and agree on the issue to be resolved at the project manager level.
- 2. The manager at the area, district, or section level will initiate the conflict resolution process.
- 3. ADOT will notify the Cooperating agency manager at the regional or deputy level.
- 4. ADOT will compile and submit all pertinent information to involved parties.
- 5. Involved parties will determine whether all information necessary for issue resolution has been received.
- 6. ADOT will hold a formal meeting (involving the first three tiers of management) to resolve the issue, followed by a 30-day review/decision period.
- 7. A decision will be made, recorded, and passed on to the appropriate team members.
- 8. The process is completed.

If issue resolution does not occur, a discussion of the issue and why a resolution could not be reached will be submitted to the heads (administrator, director, or commander) of the Cooperating agencies for further review.
